OPERATING GUIDERLINES

Share experiences of sustainable sectorial or, if necessary, intersectoral purchasing. Ensure the process of continuing education with everyone involved in the purchasing procedure, to ensure the effectiveness of NBR ISO 20400.

Implement environmental awareness programs and actions with the community, employees and supply chain, aiming at responsible consumption.

Train and audit the supply chain with periodicity and pre-defined criteria.

Strictly comply with the supply chain homologation process.

Ensure supply chain access to the documentation inherent to NBR ISO 20400.

Perform management with control actions, chain mapping, measurement, requirements reporting and rewarding best practices.

Encourage the supplier to manage sub-suppliers, with the principles of NBR ISO 20400.
